Member Comments

Financial

Discussion

- All accounts total \$66,805.70 as of end of March
- Plan to move money from secondary account to primary, then \$15,000 from primary to Dollar Bank
- Income for the month: \$11,900 (including \$3,000 from Penn State tournament and \$910 from CCAC)
- Liabilities for last month: \$19,700 (including \$1,645 for GNCC membership and \$4,500 for Allegheny County real estate tax)
- Planned liabilities for April: \$22,900 (including two GNCC payments, Hutchinson loan, logo shop restock for shirts, and Jordan's tax service for Stowe Township property tax)
- With no additional income, the club has just over three months of solvency
- Small financials report from Marie:
 - Deposited funds (3/31/25): \$3,910 (Penn State Spiel \$3,000, CCAC \$910)
 - Undeposited funds: None
 - o Donately (March 2025):
 - Members: \$50 (recurring), in-kind \$3,422.50 (property tax re-appraisal and lawyer fees)
 - Member: \$212.86 Fey Learn to Curl
 - Non-member: \$160 (recurring, 2 previous members)
 - YTD total (through April 7): \$6,410
- Question raised about GNCC insurance payment, which typically follows after the membership check is accepted

Conclusions

 GNCC membership payment was delayed due to communication issues, but has now been processed

Old Business

- Burt has uploaded almost all meeting minutes except January (which was just approved)
- Form 990 still needs to be completed with Allie (due mid-May)
- Rich to research snow removal options for next season (tabled until after current season)
- Gerry has initiated the Handle Engraving Program
- Burt has added the mission statement to the website

- Penn State College Curling Tournament was held
- Rich is working on the ad hoc committee for board nominations
- Practice ice policy from Trevor and Zach to be discussed
- Google Calendar implementation to be discussed
- Code of Conduct to be discussed
- barre3 event was canceled
- New blade/scraper to be discussed for June budget

Ad Hoc Committee for Board Nominations

- Committee is in process with Trevor's assistance
- Four candidates have been contacted about board positions
- Steve noted that while his term is not ending, he will not serve as president next year

Google Calendar

- Calendar shows color-coded events (leagues in red, Learn to Curls in blue, unavailable ice in gray)
- Calendar can be synced to the website and filtered by keywords
- Only events with specific keywords will appear on the public-facing calendar
- Recommendation to hold a 30-minute overview session for members less familiar with the system
- Calendar currently showing Thursday night practice time (7:30-8:30 PM)
- Decision to move forward with Google Calendar implementation

Events Committee

- Penn State College Curling Tournament:
 - Successfully held March 29-30
 - Low-impact event that earned \$3,000
 - Penn State participants were respectful of the facility
 - Potential for improved communication in future events now that Penn State's leadership has changed
- Tropicurl (June 5-8):
 - One team has withdrawn
 - First team on waitlist declined the spot
 - Second team on waitlist is being contacted
 - 11 teams remain on the waitlist

Communications Committee

Discussion

- Burt continues to post content to social media
- The club was featured in a New York Times article
- Need to follow up with photographer for promised pictures
- Discussed outdated information appearing in Google search results

Finance Committee

Discussion

- County website has updated lowered property assessment values for 2024 and 2025
- Contacted Jordan tax service regarding refunds; timing uncertain
- Still paying in installments for 2024 calendar year
- First 2025 invoice expected from township around August
- Must continue paying based on current invoices until new assessments are applied

Membership Committee

Discussion

- Current membership: 137 members (9 new members this month)
- Continuing Learn to Curl sessions with good attendance
- Discussing expansion of CCAC program to other schools/areas
- Planning membership committee meeting in next three weeks
- Considering summer activities to keep membership engaged (golf, bowling)
- Online reviews are extremely positive (100% on Facebook, 4.8/5 elsewhere)
- Better retention rate expected this year compared to previous years
- Current promotional offer: base membership plus unlimited spring league with coupon code

Facilities Committee

- Planning to purchase a second blade from Canada Curling Stone (to be included in budget)
- Need to coordinate blade sharpening by sending earlier this year
- Considering getting gravel for the parking lot which is getting muddy
- Exploring top of hill area for overflow parking during large events

May need to level areas with topsoil to address ankle-twisting ruts

New Business

Discussion

Annual Meeting

- Scheduled for Saturday, May 24th
- Timeline:
 - Pre-meeting activities to start at 3:00 PM (Crokinole tournament, curling challenges)
 - Potluck dinner and annual meeting to begin at 6:00 PM
- Club looking to use already allocated funds for event
- Google Doc sign-up sheet for potluck contributions
- Zach, Rich, and Gerry will lead organization
- Required elements: financial report, board member election
- Awards to be presented: Curler of the Year, Best New Curler
- Championship match could potentially be played before annual meeting

Practice Ice Policy

- Policy specifies members only, with \$10 drop-in fee for base members or members of other clubs
- Google Calendar to be used for scheduling with 24-hour advance notice required
- No more than four people permitted per sheet
- Playing simulated games during practice not permitted (with limited exceptions)
- Policy to be finalized with edits discussed and distributed

Code of Conduct

- Existing document was reviewed with concerns about legal implications
- Decision to check with other clubs (Potomac, Buck's) about their policies
- Consider creating a form for anonymous complaints
- Board will look to simplify the policy while ensuring appropriate complaint channels
- Need to establish clear process for handling complaints

May Meeting Date

- Regular meeting date would be May 13th
- Decision to move to Monday, May 5th at 6:00 PM to allow time for annual meeting preparation
- Calendar to be updated and change announced

Email Management

- Trevor raised concerns about numerous email addresses (13 groups plus shared inboxes)
- Proposal to consolidate to fewer addresses using Google Groups functionality
- Recommendation to combine related functions (e.g., info/registration, learn to curl/scheduling)

Championship Structure

- Gerry presented the bracket for championship tournament
- Eight teams selected from various leagues
- Structure addresses player overlap across multiple teams
- Timeline:
 - Round 1: April 12-25Round 2: April 26-May 9
 - o Finals: Up to annual meeting date
- Championship game could be played at 1:00 PM before annual meeting
